What can you do to help support and improve the quality of early care and education in New York State? Parents, child care providers and employers need to tell their personal story. Quality child care is needed to make a strong community. Stay connected to make a difference!

Parents who are confident about their childcare program are more confident employees!

Children who attend high quality early childhood programs are 50% less likely to need special education services and 25% less likely to be held back before third grade!

Children who attend high quality early childhood programs are less likely to drop out of school and are more likely to obtain higher levels of education!

Early care and education is defined as high quality services for all children from birth to five.

#### Quality Child Care is an Investment in Our Future!

Families need quality care to work, trusting that their children are in a warm and safe environment. Quality early childhood experiences are important for children's development, health and happiness. Children who go to a quality child care program are more likely to reach their full potential. Parents cannot find quality care they can afford. Invest in supporting early care and learning that is to everyone's benefit.

#### **Quality Child Care Providers Required!**

During the first three years 85% of brain development occurs – children need a good start! To provide quality child care, you need quality providers. Quality providers are licensed and receive training to continue their education. In Ontario, Seneca and Yates Counties, the average income for family and group child care provider's survey respondents is \$16,850 per year. Child care providers regularly leave the field because of low wages.

#### **Quality Child Care is Hard to Find!**

Parents should have options! Rotating shifts, rural areas and infant care are limited in all three counties served by Child and Family Resources. Children deserve to be well cared for. Support your Child Care Resource and Referral agencies in the efforts of affordable, safe, quality care and early learning. Parents want their children to be safe. Help is needed to make the community aware!

#### **Quality Child Care is Expensive!**

The yearly average cost of full-time child care for an infant is \$10,140 in family child care. Child care for infants in a center is \$14,144. The average cost of full-time child care for a preschool is in family child care is \$9,776 and Preschool center based care is \$11,700. The average cost of annual tuition and fees for public four-year college is \$7,292.

Child care assistance through the Department of Social Services is limited; working middle income families don't qualify for help! High child care prices make parents have to choose price over quality. Added help is needed for families not eligible for financial assistance, but not able to afford the full cost of child care.

#### Tips for writing letters or calling your Elected Officials:

- Use your own words, tell a personal story
- ❖ Be prepared know your reason and the bill you are referring to
- Speak clearly and type letters if possible
- ❖ Be reasonable and positive, ask for their position on the issue
- Make a personal connection

#### Meeting your legislator:

- Call ahead, ask for an appointment
- Prepare ahead of time, anticipate questions
- ❖ Be brief, know the issue
- ❖ Be willing to meet with legislative staff
- Keep in mind you know the early childhood issue they may not, don't be intimidated
- ❖ Be personable, prompt and courteous
- Bring your camera

#### Invite a legislator to visit your program or event:

- ❖ Be flexible
- Plan ahead
- Invite the media
- Don't forget your camera

#### Letters to the Editor:

- ❖ Be brief and know your subject
- ❖ Be legible
- Include your contact information
- Remember to make it a personal story

Most of all, for all the above tips on advocacy remember to say thank you in a personal note, send a picture that can be included on their website or newsletter, restate your facts.
